N=600 Likely Voters

Highlights of poll:

- 1. Education & Job Growth are the top two most important issues to Oklahoma voters.
- **2.** Oklahoma voters want more wind power in the state, with 65% of voters feeling that 20% wind generated electricity (which is slightly more than is currently produced) is too little.
- 3. 49 percent of Oklahoma voters feel the state should be investing more in wind energy every year, with 27% feeling they should at least keep the current investment level. (that's 76% of voters that think the tax credit should be maintained at current levels or increased).
- **4.** 56% believe the Wind Energy Production Tax Credit is a good idea (31% very good). This includes 69% of Democrats, 53% of Republicans, and 52% of Independents.
