Dear Representative Orwell:

The undersigned organizations oppose H.B. 1465 which would double the top estate tax rate in Washington from 20 percent to 40 percent, making it harder for family owned and operated businesses, farms and ranches to pass to the next generation of ownership. Only 12 states have retained an estate tax and Washington state currently has the highest rate at 20 percent and the third lowest exemption at \$2.193 million. This is on top of the current 40 percent federal estate tax with an \$11.7 million exemption. Forbes lists Washington as a top state "Where Not to Die in 2021" and hiking the already burdensome death tax in Washington would encourage businesses and retirees to leave the state.

Washington's residents also oppose the estate tax, a 2016 poll conducted by YouGov found that 56 percent of Washington likely voters want to see the estate tax repealed. H.B. 1465 would do the opposite of what the majority of Washingtonians support. In fact, only 13 percent supported increasing the estate tax as H.B. 1465 would do.

It makes no sense to require grieving families to pay a confiscatory tax on their loved one's nest egg. Far too often this tax is paid by selling family assets like farms and businesses. Other times, employees of the family business must be laid off and payrolls slashed. No one should be punished for fulfilling the American dream.

The negative effects of the estate tax make permanent repeal the only solution for family businesses and farms. This legislation will hurt Washington's family businesses, destroy jobs, and hurt the state's economy.




